The ThaiHealth Academy has received financing from the World Bank toward the cost of the Enhancing Psychosocial Services for Traumatized Persons in Conflict-Affected Areas in Thailand's Deep South and intends to apply part of the proceeds for the following consulting services.

The consulting services (“the Services”) include providing external academic quality control consultancy to ensure the quality and academic standards of project outputs under the project “Psychosocial Support for Vulnerable Populations in the Southern Border Provinces of Thailand.” The Consultant will provide academic quality assurance and technical advice for the development and review of curriculum manuals, referral system manuals, academic publications (including online proceedings), e-learning materials, and the final project report. The assignment is expected to be carried out within 80 days from the contract signing date.

The ThaiHealth Academy now invites eligible consulting firms (“Consultants”) to indicate their interest in providing the Services. Interested Consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the Services.

The attention of interested Consultants is drawn to paragraph 3.14, 3.16 and 3.17 of the World Bank’s Procurement Regulations for IPF Borrowers date September 2023 (“the Regulations”), setting forth the World Bank’s policy on conflict of interest.

The best qualified firm to carry out the services will be selected in accordance with the Consultant’s Qualifications Based Selection (CQS) method set out in the Regulations and based on the following criteria:

- Must be a juristic person possessing expertise in academic services, curriculum development, or academic quality control at the national or international level.
- Must have a minimum of five (5) years of experience in providing consultancy services in learning process design, capacity building, or academic-related work, particularly in the fields of social sciences, culture, psychology, or health.

- Must demonstrate proven experience and expertise in the design of learning processes and specialized in-depth learning methodologies, with due consideration to the context of personnel, culture, society, and community dynamics.
- Must have prior experience in collaborating with government agencies, private sector entities, or projects supported by relevant organizations.
